TO WHOM IT MAY CONCERN

WHEREAS, GENERAL DEVELOPMENT CORPORATION, A Delaware Corporation, authorized to transact business in Florida, is the owner of the following described property, situate, lying and being in Charlotte County, Florida, to-wit:

PORT CHARLOTTE SUBDIVISION, SECTION 93, a subdivision in Charlotte County, Florida, according to the Plat thereof, recorded in Plat Book 9 at Pages 1A thru Z4 of the Public Records of Charlotte County, Florida;

and,

WHEREAS, GENERAL DEVELOPMENT CORPORATION, A Delaware Corporation, has caused to have recorded a Declaration of Restrictions, Reservations, Easements and Covenants covering Port Charlotte Subdivision, Section 93, located in Charlotte County, Florida, which Declaration appears of record in Official Record Book 338, Pages 559 thru 562 of said Charlotte County Public Records; and

WHEREAS, GENERAL DEVELOPMENT CORPORATION has caused to be recorded an Amendment to the Declaration of Restrictions dated August 13, 1970, and filed August 19, 1970, in the Public Records of Charlotte County, Florida, in Official Record Book 341, Pages 523 and 524; and

WHEREAS, GENERAL DEVELOPMENT CORPORATION, a Delaware Corporation, authorized to do business in the State of Florida is at present the majority land owner of said Port Charlotte Subdivision Section 93; and

WHEREAS, subsequent to the date of the recording of said Declaration, conditions have substantially changed to cause the following changes to be made.

NOW THEREFORE, GENERAL DEVELOPMENT CORPORATION does hereby and herewith file this Supplementary Declaration of Restrictions for the following purposes and to affect only the following described lots or parcels of land, to-wit:

1. Notwithstanding anything contained in the original Declaration of Restrictions dated April 6, 1970, and filed in the Public Records of Charlotte County, Florida in Official Record Book 338 at Pages 559 thru 562 as amended by Amendment to Declaration of Restrictions filed in Official Record Book 341 at Pages 523 and 524 of said Public Records of Charlotte County, Florida, GENERAL DEVELOPMENT CORPORATION declares that Lot 1 in Block 4920 of said PORT CHARLOTTE SUBDIVISION, SECTION 93, a subdivision in Charlotte County, Florida, according to the plat thereof, recorded in Plat Book 9, at Pages 1A through 24 of the Public Records of Charlotte County, Florida, is dedicated to the use of GENERAL DEVELOPMENT CORPORATION, its successors and assigns, for the sole purpose of using the same for construction and maintenance of utility facilities.

2. In all other respects, all statements contained in the original Declaration of Restrictions and Covenants as amended shall remain in full force and effect as if set forth verbatim herein and are herewith ratified, approved and confirmed.

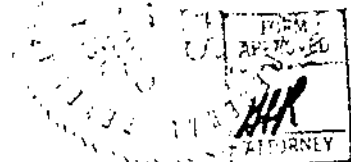
